What You Need to Know: Sexual and Gender-Based Violence and Harassment

Overview:

If you have experienced sexual or gender-based violence or harassment, there are multiple channels for obtaining information, assistance, and support to ensure your health and safety, both physical and emotional. This resource is intended to provide an overview of the ways in which Emory University and the local community can support you, including by providing information about and access to resources and reporting options (if you decide to report your experience).

Please note that the term "sexual or gender-based violence" is used here as an umbrella term to refer to all Prohibited Conduct as defined in Emory's Sex and Gender-Based Harassment and Discrimination Policy, <u>Policy 8.2</u>. Conduct prohibited by Policy 8.2 includes the following:

- sexual assault (including nonconsensual sexual contact or nonconsensual sexual intercourse, or attempts to commit either);
- dating violence;
- domestic violence;
- intimate partner violence;
- stalking;
- sexual exploitation;
- sexual and gender-based harassment; and
- retaliation against any person for making a good faith report of prohibited conduct or for participating in any proceedings under these policies.

Detailed definitions of these and other important terms, including "affirmative consent" and "incapacitation," are set forth in Policy 8.2.

What should I do immediately after an incident of sexual or gender-based violence or harassment?

While it can be challenging to determine what steps to take after an incident, the following are recommended for anyone who has experienced sexual or gender-based violence or harassment:

1. Seek Medical Attention

2. Preserve Evidence

Whether or not you know that you will pursue a Title IX process, criminal process with the police, or legal prosecution, if the incident occurred within the last <u>120</u> <u>hours</u>, you should <u>strongly consider</u> seeking medical care and preserving evidence.

You are not obligated to pursue criminal steps if you get a medical examination and collect evidence. Additionally, you should consider saving text messages, phone records, social media messages, and any other information you believe would be helpful if you choose to pursue any of the above-mentioned processes.

3. Connect with Confidential Resources

You have access to numerous confidential resources for emotional support and confidential counseling as you consider the next steps for safety planning, counseling, reporting, and accommodations. Emory understands that you may wish to discuss an incident in a confidential manner with a resource who is not required to report the incident to the Department of Title IX. Emory's confidential resources are as follows:

a. Office of Respect: Office of Respect provides 24-hour support resources for Emory students impacted by sexual and/or relationship-based harm. The office aims to provide support; help students learn about their options and rights; assist with safety planning; provide legal and medical accompaniment; offer academic assistance, and individual and group counseling.

The Office of Respect provides 24/7 crisis response. You can reach the Office of Respect's 24/7 Crisis Response Line at 470-270-5360.

b. <u>Faculty and Staff Assistance Program (FSAP)</u>: FSAP serves both the Atlanta and Oxford campuses and offers a variety of programs, services, and resources to promote emotional, behavioral, and workplace health to Emory employees.

The FSAP offers emergency consultations during regular business hours and after-hours on-call services 24 hours a day/7 days per week including holidays by calling the main number – 404-727-WELL (9355).

c. Emory Ombuds Office: The Emory Ombuds Office serves both the Atlanta and Oxford campuses. It is a confidential, safe space where students, faculty, and staff can discuss concerns about misunderstandings, incivility, or possible wrongdoing.

d. Office of Spiritual and Religious Life (OSRL) - Atlanta Campus and Office of Religious and Spiritual Life (ORSL) - Oxford Campus: OSRL and ORSL have separate offices on the Atlanta and Oxford campuses. These offices support the university's religious and philosophical diversity by providing opportunities to engage with spiritual life on campus through worship, meditation, education, service, social justice, and interfaith engagement.

e. Counseling and Psychological Services (CAPS) - Atlanta Campus and Counseling and Career Services (CCS) - Oxford Campus: CAPS at the Atlanta campus and CCS at the Oxford campus offer professional, licensed counselors who provide mental health counseling to students.

f. Student Health Services (SHS) – Atlanta Campus and Oxford Campus: Student Health Services has separate offices on the Atlanta and Oxford campuses and provides healthcare services to students.

Please Note: In limited circumstances, these privileged and confidential resources may have reporting or other obligations under state law and may have an obligation to follow moral and ethical guidelines, for example, in matters related to child or elder abuse. These reporting or other obligations may limit the extent to which the professional may maintain a Complainant's confidentiality, especially in cases of imminent danger.

What other resources should I consider contacting after an incident of sexual or gender-based violence or harassment?

1. Connect with a Non-Confidential Resource

a. Emory Police Department – Atlanta and Oxford Campus

Depending on the location of the incident, the Emory Police Department or a local police authority can assist you.

EPD can make referrals to campus and community support resources and can investigate sexual misconduct to determine if criminal charges are warranted. Calling

EPD (or another law enforcement agency) does not require that a person impacted by sexual misconduct press charges.

You can initiate a report by calling the Emory Police Department at **404-727-6111**. You can also call **911** and be connected directly to the jurisdiction's emergency switchboard. If, after calling 911, you want to be connected with EPD, you can inform the dispatcher to be transferred to EPD.

b. Department of Title IX – Atlanta and Oxford Campus

The Department of Title IX supports the university's commitment by fairly and equitably responding to reports of sexual harassment, sexual assault, domestic violence, intimate partner violence, stalking, and gender-based harassment. The university's process is independent from any criminal process.

The Department of Title IX also connects individuals with campus resources and provides supportive measures. Supportive Measures are designed to restore or preserve access to the University's education programs and activities, protect the safety of all parties and the University's educational or work environment, and/or deter Prohibited Conduct, while not being punitive in nature or unreasonably burdening the other party.
